Release of Liability - Client Consent

I understand and agree to receive the services delivered as part of the Boys and Girls Club of Drayton Valley program. Programming activities such as recreational activities and outings involve certain elements of risk. Injuries may occur while participating in these activities. The following list includes, but is not limited to examples of the types of injury, which may result from participating in the above-mentioned activities.

1. Traffic Accident on the van or bus while being transported to and from activities.
2. Youth tripping, falling or injuring themselves while participating in programs.
3. Food allergy/choking while eating snack or lunch.
4. A drowning while participating in a swimming activity.

The risk of sustaining these types of injuries result from the nature of the activity and can occur without fault of either the participant, or the Boys and Girls Club, its employees/agents or the facility where the activity is taking place. By choosing to take part in the Boys and Girls Club programs, you are accepting risk that you/your child may be injured. The chance of an injury occurring can be reduced by carefully following instructions at all times while engaged in program activities.
